Report to the Board: Auxiliary Unit

In January 2020, the OSPS Auxiliary Unit members volunteered a total of 122 hours, which included two members who had 13 hours each, split between events and uniform patrol. Our Auxiliary Sergeant, Jessica Brown, further contributed a total of 21 hours which included the planning and interviewing of several applicants for our NEW up and coming Auxiliary class in 2020.

In January we had Auxiliary Member Sarah Stevens resign after realizing she was unable to maintain her commitment level to the Unit. In her resignation letter Auxiliary Stevens thanked the Owen Sound Police Service and the members of the Auxiliary Unit for the opportunity to learn and be a part of her community through the Owen Sound Police Service. She wished the Unit her very best in their future endeavors.

January was also the first month that our new Auxiliary Liaison Officer, Sgt. Liz Cranny, joined the Unit. She was welcomed by the members of the Unit and they are looking forward to the new ideas, additional training and energy that she will contribute to the Auxiliary moving forward.

Insp. Bishop, Sgt. Liz Cranny and Auxiliary Sgt. Brown completed the interviews for the new Auxiliary recruits and 8 persons have been selected to commence training which will begin at the end of February 2020. The training will consist of approximately 30 hours of in-class and practical hands on training, including police powers of arrest, the charter of rights and freedoms, criminal code offences, defensive tactics, handcuffing and community policing. Provided all new members are successful with their training, it will bring the Auxiliary Unit numbers up to a total of 25 volunteers.



Report to the Board: Criminal Investigations Branch and Drug Enforcement

Criminal Investigations

In January, 2020 members of the Criminal Investigations Branch conducted investigations into numerous offences including Sexual Assaults, Assault, Fraud, Break and Enter, Robbery and sudden death.

During the early morning hours of January 04, 2020 an altercation took place at the Pizza Pizza restaurant downtown. During the fight, the accused pulled out a knife and the victim was subsequently stabbed in the chest and also had several fingers cut as he grasped the knife's blade. The chest wound was very minor as the blade was prevented from penetrating very deep by the victim's defensive action of grabbing the blade. The victim's hand required several stitches. The Criminal Investigations Branch interviewed numerous witnesses and reviewed surveillance video from multiple sources which eventually resulted in the identification of the accused. A 35-year-old Owen Sound man has been arrested and charged with Assault with a Weapon, Assault Causing Bodily Harm and Possession of a Weapon for a Dangerous Purpose.

On January 22, 2020 at 11:30 a.m. a lone male entered the CIBC bank with his face concealed. The man displayed a knife in a threatening manner to the teller and directed her to quickly place money into a bag. The man then fled the bank with an undisclosed quantity of cash. Members of the Uniform Branch and Criminal Investigations Branch responded to the call and initiated an investigation. Numerous investigative techniques were utilized which resulted in the identification of a 34-year-old male from the Chatsworth area as being responsible for committing the robbery. The man was arrested and the stolen cash from the robbery was recovered. The accused is currently charged with Robbery while armed with an offensive weapon, Disguise with Intent to Commit an Indictable Offence and Possession of Proceeds of Crime.

On January 30, 2020 a man broke into the Sydenham condominium building and stole thousands of dollars' worth of power tools that belonged to contractors who were working at the site. Police investigated the break-in and were able to identify, locate and arrest the accused by 2 p.m. that same day. At the time of his arrest, the man was found in possession of some of the power tools that he had stolen. Members of the Criminal Investigations Branch later obtained a warrant to search the hotel room that the accused had been staying in at the Travelodge Hotel. Inside of the hotel room, Investigators located all of the remaining power tools that had been stolen in addition to other items of stolen property. A 30-year-old man of no fixed address, has been charged with numerous criminal offences including Break, Enter and Theft as well as Possession of Property Obtained by Crime.

Detective Hartley delivered training to all officers during winter block training sessions on MMHART. More specifically, officers were trained on the theory and usage of the Brief Mental Health Screener Form and the Transfer of Custody Form that must be completed when dealing with mental health patients at the Owen Sound Hospital.

Drug Enforcement and Intelligence

The Drugs and Intelligence Unit continues to investigate persons involved in the trafficking of various drugs in Owen Sound and Grey-Bruce. As in previous months, the focus continues to be on Fentanyl and Crystal Methamphetamine.

Just before noon on January 09, 2020 a drug trafficking investigation conducted by the Owen Sound Police Service was concluded with the arrest of a 25-year-old Owen Sound male. Members of the Drug Enforcement Unit and Criminal Investigations Branch as well as the Barrie Police Service conducted observations of the male as he travelled to and from Barrie to meet his drug supplier. Upon returning to Owen Sound police arrested the man on Alpha Street and found him in possession of more than \$2,500 worth of highly toxic purple Fentanyl as well as other items associated with drug use and trafficking. The man has been charged under the Controlled Drugs and Substances Act with Possession of Fentanyl for the Purpose of Trafficking.

On January 27, 2020 members of the Drug and Intelligence Unit began assisting the Toronto Police Service Hold Up Squad in conducting surveillance of two suspects who were recently involved in robberies of multiple LCBO locations in the Greater Toronto Area. At the conclusion of multiple days of observations, one of the males was arrested by Owen Sound Police and custody of him was transferred to the Toronto Police Service. The second involved male was located and arrested in the City of Toronto. Both males have been charged with multiple counts of robbery.



Number of Events by Priority - JANUARY 2020








Number of Events by Day of Week/Hour of Day - JANUARY 2020











Report to the Board: 2019 - Building Deficiency and Health and Safety Issues

In 2018 it was identified that the panic strips in the cell area becoming less responsive due to age. There was a partial replacement of these strips in 2019. It is planned that the remaining panic strips will be replaced in 2020. No issues occurred involving the panic strips in 2019.

In March 2019, it was identified by police staff that pieces of brick were falling from the top of the building beside the public entrance. The brick work near the roof of the building had deteriorated and the faces of the brick were falling near the entrance. This area was barricaded. A site inspection determined that there was also brick deterioration on the south side of the building as well. Repairs were made to the front brick work in July. During the time of the repairs, the public was directed to the Barclay Room entrance which was staffed by a records clerk and a police officer for security. The brick work on the south side of the building is to be completed in 2020.

In July 2019, a complaint of air quality was received that an employee working in the dispatch area was becoming congested while at work. The issue was identified to facilities and air quality testing occurred in August. No dangerous substances or particulate was detected however it was determined that there was not adequate air flow. It was found that an air handler was broken. This has since been repaired and the building has been equipped with a Building Automation System (BAS). There are continuing issues with uncomfortable temperatures and stale air. These issues are being worked on by facilities and the contractor.

Processes for work being completed at the police service by city facilities are being reviewed.



Report to the Board: 2019 - Firearms Report

Firearms Acquired in 2019

The Owen Sound Police Service took possession of twenty-nine firearms in 2019. Of those, eighteen were rifles, ten were shotguns and one was a handgun.

Of the twenty-nine firearms received in 2019, twenty-two were surrendered for destruction by the lawful owners or next-of -kin of deceased owners. The owner of the handgun turned over to police is unknown at this time and it is being held for investigation purposes.

Seven of the firearms are being held pending criminal matters or were turned over as per court order.

Firearms Currently in Possession of the Owen Sound Police Service

The Owen Sound Police Service currently has 69 firearms in their possession, consisting of thirty-five rifles, twenty shotguns and fourteen handguns.

Twelve of the remaining sixty-nine firearms are for criminal cases or being held as per court orders. Three firearms are being held for investigation purposes.

Fifty-four firearms are being held for destruction. The Owen Sound Police Service is currently seeking a more cost-efficient method of firearms disposal and destruction is set for mid April 2020.

All required reports have been submitted to the Provincial Weapons Enforcement Unit and RCMP.



Report to the Board: 2019 – Joint Force Operations

In 2019, the Owen Sound Police Service continued to work collaboratively with several Police Agencies to ensure public safety and address criminal activity.

The Criminal Investigation Branch partnered with the Ontario Provincial Police – Grey Bruce Community Street Crime Unit in three joint drug trafficking investigations. In July of 2019 three individuals were arrested at the conclusion of a three-month investigation into the distribution of crystal methamphetamine throughout Grey, Bruce and Perth counties. A total of three kilograms of Methamphetamine was seized in the investigation.

The Criminal Investigations Branch also conducted joint force operations with the Saugeen Shores Police Service on two separate occasions. In one investigation three unlicensed cannabis store front dispensaries operating in Owen Sound, Port Elgin and Southampton were searched and shut down with the owners and operators being charged under the Cannabis Act.

The Owen Sound Police Service Drug Enforcement Unit assisted the Guelph Police Service in 'Project Raptor'. This project focused on Fentanyl trafficking in the Guelph area. Two Owen Sound residents were arrested in the project which directly assisted in identifying individuals further up the supply chain. Approximately 500 grams of Fentanyl, was seized in the project along with two loaded handguns and a large quantity of cash proceeds.

In August of 2019 an Owen Sound Police Service drug investigation identified a Fentanyl supplier from the Greater Toronto Area. A joint investigation between Owen Sound Police and the Toronto Police Service Guns and Gangs Task Force resulted in the arrest of the male Fentanyl trafficker in the City of Toronto. Police seized approximately \$80,000 worth of Fentanyl and \$8,000 worth of Cocaine along with 200 rounds of handgun ammunition in the investigation.

In addition to the above described cases, the Criminal Investigations Branch also conducted joint force investigations with Waterloo Regional Police, Orangeville Police Service, Shelburne Police Service and Hanover Police Service.

In addition to these specific cases the Owen Sound Police Criminal Investigations Branch worked throughout 2019 with local O.P.P. as well as Saugeen Shores, Hanover and West Grey Police Services for missing and wanted persons. Our Police Service was again involved in Project Northern Spotlight which is a collaborative project for human trafficking interventions and is conducted in partnership with all the local Police Agencies.

Joint Force Operations are also held to ensure our roadways are safe. In 2019, the Owen Sound Police partnered with West Grey, Hanover, Saugeen Shores and the Ontario Provincial Police to provide robust RIDE programs for large scale events occurring in each respective jurisdiction. In Owen Sound, the joint initiative occurred on in September during a busy evening at the Salmon Spectacular.

Any member of the public may make a complaint about the policies or service of a police service or the conduct of a police officer. The Office of the Independent Police Review Director (OIPRD) receives, manages and oversees all complaints against police in Ontario. Upon receiving a complaint, the OIPRD can elect to: Conduct an investigation, screen the complaint out as being not in the public interest to proceed, direct an investigation to be conducted by the police service of the respondent officers or direct an investigation to be conducted by another police service.

In 2019, two complaints were received by the OIPRD. One of these complaints were in relation to officer conduct and one in relation to service. There were no complaints related to policy. Both complaints were investigated by a senior officer and found to be unsubstantiated. Also, during 2019 a conduct complaint from 2018 was investigated by a senior officer and found to be unsubstantiated. Another complaint from 2018 was investigated by the Professional Standards section of the OPP and found to be unsubstantiated.

Report to the Board: 2019 – Use of Force Training

Police Officers and Special Constables are required to be certified on an annual basis in Use of Force. The Owen Sound Police have three qualified Use of Force Instructors. Yearly re-fresher training is required for Defensive Tactics while requalification is required annually for Firearms and Conducted Energy Weapons.

Annual training in Defensive Tactics and CEW occurred during our winter block training session. Sworn officers and Special Constables were trained in Defensive Tactics and sworn officers were requalified in CEW. Firearm requalification occurred for sworn officers in May 2019 at the East Grey Hunters and Anglers Association Club. Officers are recertified in the use of their handgun, shotgun and C8 rifle. The officers were also trained in Immediate Rapid Deployment.

All members required to participate and pass annual regualification successfully did so.



Report to the Board: Annual Site Assessment by the Ontario Sex Offender Registry – November 2019

The Ontario Sex Offender Registry (OSOR) captures details of individuals convicted of designated offences. The OSOR is an investigative and crime prevention tool that provides valuable information to police services relating to sex offenders residing within their jurisdiction and within the Province of Ontario. Offenders who are non-compliant are those who have failed to comply with Christopher's Law and/or the Sex Offender Information Registry Act (SOIRA). The OSOR recognizes that there will be individuals who will fail to comply and it is recommended that warrants or charges are sought as a risk management strategy. Low offender compliance poses a significant risk to public safety and creates a growing liability for police services if left unaddressed.

The OSOR is mandated to conduct an annual Site Assessment with all police agencies in Ontario. This annual assessment took place November 13, 2019. Special Constable Corrina Fernando is assigned as the OSOR Registrar for the Owen Sound Police Service. The OSOR compliance rate for OSPS was 95.7% slightly below the provincial compliance rate of 97%. Since the assessment date the compliance rate has dipped to 92.3% and warrants have been issued for the two non-compliant offenders. Due to the relatively small number of registrants locally even one person being non-compliant can dramatically affect the percentage of compliance. There are two individuals who are non-compliant and bringing down the overall compliance. One individual convicted in Owen Sound moved out of the Province several years ago making enforcement of the provincial legislation difficult. The second individual had an Owen Sound address and was dealt with in Owen Sound Court but has moved from the area and is of NFA. This individual remains connected to Owen Sound despite not living locally. Attempts have been made to change the recorded address and a warrant has been issued requesting to make that change.

The Assessment went on to compliment S/Cst. Fernando for the work, effort and offender management skills that she puts into her daily routine. S/Cst. Fernando was also complimented on her diligence in tracing two non-compliant National Sex Offender Registry (NSOR) sex offenders and bringing them into compliance. A detailed report relating to all offender records for the Owen Sound Police jurisdiction was provided as part of the assessment and S/Cst. Fernando has worked through all of the items and done an excellent job filling in all mandatory offender case management.

A copy of the current Ministry Guidelines LE-046 was reviewed and the assessment indicated that there are no deficiencies noted with our current policies. The policy was last reviewed in 2018 and remains up to date and will be reviewed as any legislative changes are brought forward.
